



## **Dual Credit Academic Probation Advising Packet**

At South Plains College, students are placed on academic probation at the end of any term when a cumulative grade point average of at least 2.00 is not maintained in all college-level courses. A student may still enroll while they are on academic probation in succeeding semesters, provided they achieve at least a 2.00 semester GPA in each sequential semester. Students will be removed from academic probation only when they have raised their cumulative GPA to at least 2.0.

If a student is placed on academic probation, the student is expected to complete an Academic Probation packet, along with a meeting between the student and a member of SPC's Dual Credit Office. The results of this meeting may lead to the development of, or changes to, a student's educational success plan depending on the student's previous grades, their high school graduation requirements, or other factors which might impact their success in any upcoming college courses.

The following steps are listed for students on academic probation:

Step 1 – Students should print out the Academic Probation packet and review the attached “Academic Probation Preparation” flyer for additional information surrounding this process and the implications associated with being on academic probation.

Step 2 – Students will then complete the Academic Probation exercise and contact their high school counselor who will assist them in contacting the Dual Credit Office to schedule an online appointment or conference call. A student's probation packet will need to be completed and electronically submitted to the Dual Credit office prior to their official meeting.

Step 3 – Each student, their high school counselor, and a staff member from the Dual Credit Office will review the probation packet. Students will then receive recommendations from SPC's dual credit advising staff, that may include restricting the number of credit hours that may be taken in future semesters, or even retaking courses for grade replacement purposes.

Step 4 – Students will still be expected to continue meeting with their high school counselor throughout the semester, keeping the Dual Credit Office informed of any issues or questions that may arise while working through the education success plan that was prescribed prior to enrollment.



## Dual Credit Academic Probation Preparation

In preparation for an upcoming Advising appointment or conference call, dual credit students should:

- Review their unofficial transcript on Texan Connect before visiting with an SPC staff member. Reflect on behaviors that might affect their GPA, to help them set goals and incorporate good study habits for the upcoming semester.
- Consider taking fewer hours in the upcoming semester...additionally, if the student has failed one or more classes, re-taking that coursework as soon as possible should be immediately considered – this is the fastest way to improve your GPA.

Research has shown that students who take fewer hours while on academic probation are more successful in completing their courses and raising their GPA.

### Reminders:

- Be sure that the required Probation exercise is completed **before** the appointment. This exercise and time of reflection is important – it will assist the student's advisor in developing their Educational Success Plan.
- Each student, their high school counselor, and a member of the Dual Credit Office will review future courses selections, ensuring they directly map to the academic recommendations outlined in the student's Educational Success Plan.
