Course Description: This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirements for teacher certification.

Course Purpose: Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. This course meets the statutory requirements as set forth by the state of Texas.

- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas Government.
- 5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
- 6. Analyze the state and local election process.
- 7. Describe the rights and responsibilities of citizens.
- 8. Analyze issues, policies, and political culture of Texas.

Assignments

Quizzes (15%)

Weeks that cover a textbook chapter will include a quiz. A typical quiz will have 10 questions (e.g., multiple choice, true/false, free response) based on the assigned reading and videos for that particular week. I will not accept late work for quizzes, but your two lowest quiz grades will be dropped. Also, the syllabus quiz will count as a regular quiz.

Discussions (20%)

There are five discussion assignments in this course. Some discussion threads will be based on a current event in Texas politics, while other discussions will examine the structure of Texas government. The purpose of the discussions is for students to demonstrate their knowledge of course material and engage with other students on important topics in Texas politics.

For each discussion, you will be required to make an initial post in which you answer the question(s) posed in the prompt. After you make your initial post, you must read the posts from your fellow classmates and make an additional post in response to another student's post. I will accept late discussion assignments, but there will be a 10-point deduction for every day that it is late.

Finally, all students are required to maintain professional language in online discussions. If you offer criticism, do it in a polite and constructive manner. For example, avoid name-calling, curse words, and slurs. Any text that a reasonable person would find offensive will likely result in a loss of credit for the assignment. If you need further clarification, please contact the instructor.

Short Answer Assignments (25%)

There are four short answer assignments in this course. Each assignment will ask you a series of questions covering important topics in the readings. It is important that you accurately answer all parts of the questions and cite the textbook (or another reputable source) to support your answers. All short answer assignments will be submitted through Blackboard. Late short answer assignments will be accepted, but there is a 10-point deduction for every day that it is late.

Letter to the Editor (10%)

This assignment requires you to critically read and assess a newspaper article or editorial. Then, you will write a letter to the editor in which you develop a persuasive argument and a call to action. More information on this assignment will be provided to you later in the semester.

Exams (30%)

There are two exams (midterm and final) in this course. Both exams will have a combination of 50 multiple-choice, true/false, and free response questions.
